SOAS SU is the official representative body of c.7000 students at SOAS and is an independant charity. We work in partnership with the university to deliver the best outcomes for students. About the SU

Charity

We are a registered charity. Our primary source of income is a block grant from SOAS, University of London and from our commercial outlets. We sit at the heart of the student experience delivering a range of services, events and activities. The Trustees are responsible for the charity, delegating day to day management to the Chief Exec. We employ a small team of permanent staff and key student staff roles, working alongside the elected officers to ensure that every student has the best experience.

Representation

We ensure that students are represented on every level at the university. From facilitating the Student Rep scheme in partnership with the university, through to the elected officers. We also enable members to make change through a range of democratic processes through setting union priorities and electing their representatives.

Societies and Sports Teams

We support students with personal growth through supporting over 100 Societies and Sports Teams which are student led and encompass everything from cultural groups to sports teams.

Venues and Events

We have a common room, bar, shop and coffee shop in the heart of Bloomsbury and our space is growing, with a newly refurbished and expanded spaces. The money we receive through our commercial outlets goes straight back into the services we provide for students.

Support

We support students during their time at university through our Advice Service and the Enough is Enough Consent Scheme.

About The Role

Role Title: External Trustee (Finance and Commercial) and Student Trustees

Role Type: Voluntary, reasonable expenses covered

Period in Office: Four year term, but may serve up to two terms

Key Relationships: Sabbatical Trustees, Student Trustees, External Trustees, CEO

Minimum Time Requirement: 4 main board meetings per year, plus additional sub-committee attendance and time required to read meeting papers.

Duties and Purpose

Trustees are responsible for the legal, financial and reputational aspects of the Union. Trustees are responsible for ensuring that the Union pursues its charitable objectives and strategic purpose. They do this by:

- Ensure that the work of the SU reflects it diverse membership
- Determine the overall strategic direction of the SU and develop the organisation in line with the principles of good governance
- Assist the development of the SU by overseeing clear strategic planning based on a coherent understanding of the environment in which the organisation operates
- Ensure that SU operates in an effective, responsible and accountable manner within the legal and financial requirements of a charitable organisation
- Maintain sound financial oversight and control of funds and resources
- Identify and oversee the management, financial, legal and reputational risk to the SU

Eligbility

In order to be eligible to be a Trustee of SOAS SU you will need to meet the following conditions:

- 1. I am over the age of 18;
- 2.I am willing to act as a charity trustee and become a member of the Charity;
- 3.I am capable of managing and administering my own affairs;
- 4. I understand the Charity's purposes (objects); and
- 5. I am not disqualified, or otherwise prevented, from acting as a charity trustee and confirm that:
- 6. I do not have an unspent conviction for any criminal offence;
- 7.I am not an undischarged bankrupt (or subject to bankruptcy or debt relief restrictions, an interim order, a debt relief order or sequestration in Scotland);
- 8. I have not entered into a compromise or arrangement with my creditors (such as an individual voluntary arrangement (IVA) or deed of arrangement) from which I have not been discharged;
- 9.I have not been disqualified from being a company director or removed from being in the management or control of any organisation; or disqualified by or removed as a trustee, charity trustee, officer, or employee of a charity by an order of the Charity Commission, the Office of the Scottish Charity Regulator, the Charity Commission for Northern Ireland or the High Court;
- 10. I am not a designated person under anti-terrorism legislation;
- 11. I am not on the sex offenders' register;
- 12.I have not been found in contempt of court for making (or causing to be made) a false statement; or guilty of disobeying an order or direction of the Charity Commission;
- 13.I am not disqualified or barred from acting as a trustee of this charity under the Safeguarding Vulnerable Groups Act 2006;
- 14. I do not work for/receive remuneration from SOAS SU
